GEMS TANZANITE ONE AND BERYL (T1B) FAMILY PRACTITIONER (FP) NETWORK: IMPORTANT REMINDERS AND BENEFIT ENHANCEMENTS FOR 2024

GEMS considers the Family Practitioner (FP) to be at the heart of the healthcare process and appreciates the intensive work done by FPs to ensure that our more than 2.2 million beneficiaries receive the quality healthcare they require.

The purpose of this communication is to update you on the following:

- 1. FP and Family Physician tariff increases;
- 2. Enhanced paediatric benefit;
- 3. Continuous Glucose Monitors (CGM) and insulin pumps;
- 4. Change in GEMS Hospital Network non-network co-payment;
- 5 PPE Re-imbursement; and
- 6. GEMS Practitioner Application / Portal.

1. FP and Family Physician Tariff increases for 2024

The following tariff increases are applicable to T1B FPs and Family Physicians from 1 January 2024:

Important reminder for Dispensing TB FPs and Family Physicians: Dispensing Network FPs and Family Physicians can write a prescription in instances where they do not have the relevant medicines in stock. The medicines will have to be dispensed by a Network pharmacy and will be limited to three (3) scripts of up to a maximum of R242 each per beneficiary per annum.

2. Enhanced Paediatric Benefit

From 2024, GEMS will fund medicines for intestinal flora if prescribed for beneficiaries up to and including 6 years of age. This will pay from available benefits and excludes self-medication and over-the-counter purchases.

3. Continuous Glucose Monitors (CGM) and Insulin Pumps

From 2024, GEMS will fund one CGM / Insulin Pump (and consumables) subject to clinical protocols and available benefits every 5 years for beneficiaries with Type 1 Diabetes who are under the age of 18.

4. GEMS Hospital Network

Members on the Tanzanite One and Emerald Value options must make use of the GEMS Hospital Network for hospital admission. Voluntary use of a non-network hospital will result in a co-payment of R15 000. To view and download the GEMS Hospital Network list, please access the GEMS website.

In order to assist your patient on the Tanzanite One option to avoid a non-network copayment, please refer them to a specialist based at a network hospital.

5. PPE Re-imbursement

The reimbursement of PPE will be discontinued from 1 January 2024.

6. GEMS Practitioner Application / Portal

The Scheme is pleased to announce the newly redesigned and upgraded GEMS Practitioner Portal and Mobile Application. The platforms provide a more personalised and improved functionality and are user-friendly. Registration details and links are available on the GEMS website (www.gems.gov.za).

Please note that you **do not** need to sign or return the agreement. Should you have any objections to the information contained in this communication, you are welcome to inform us in writing. The objection must reach the Scheme on or before **Friday 26 January 2024**, failing which it shall be deemed that you agree to the contents hereof, and shall be legally bound thereto as a GEMS TB Network Provider.
