Network agreements

Kindly note that, if you have entered into any reimbursement agreement directly with Momentum Health Solutions or any of these medical schemes, which may contain a different set of contracted rates, these will take precedence over the scheme rates on the Momentum Health Solutions provider portal as mentioned above.

However, it is also possible that some of these agreements might be dependent on a factor of scheme rate, which will require you to update your billing systems with the appropriate revised rates.

Medication and consumable reimbursement for 2024

Doctor's dispensing fees and markups on consumables will be reimbursed in line with the legislated maximum, which is currently 30% with a maximum of R43.40 per item (excluding VAT) applicable to items costing more than R138 (including VAT) for all funders under our administration.
