RE: IMPORTANT NOTICE: PCNS 2026 ANNUAL RENEWAL REGISTRATION FEE

This notice serves to inform you that the 2026 Annual Renewal Registration fee is now due and is payable by the 31st of March 2026.

The 2026 PCNS annual fee is **R 443.00 VAT inclusive**. Kindly refer to the attached account statement for the full balance payable.

The PCN System is administered by BHF in accordance with Regulations 1 and 5 of the Medical Schemes Act (Act 131 of 1998). The Practice Code Number "means the number allotted to a supplier of a relevant health service..." In terms of Regulation 5, "the practice code number, group practice number, and individual provider registration number issued by the registering authorities for providers..." must be included in the account or statement contemplated in section 59(1) of the Act, section (e).

Please note you are required to confirm and or update your personal and practice details to ensure the PCNS has the most current practice and personal information. All licensed facilities except pharmacies are required to supply BHF with a valid license on an annual basis; failure to submit a valid license can result in the practice number being suspended within 5 working days from the date of expiry of the previously submitted license. Please note that non-compliance by health service providers in updating their details or payment may result in the suspension of your practice number, which will impact your claims experience with Medical Schemes.
